#### ***Voluntary Assisted Dying Implementation Leadership Team - Communiqué May 2021***

##### ***Message from the Chair, Dr Scott Blackwell***

*Most of the preparation around the many facets of voluntary assisted dying is nearing completion within the 8 workstream structure of the Implementation Leadership Team (ILT). We have ensured relevant focus has been on the preparedness of the health industry and in particular the clinicians who will be affected by or involved in voluntary assisted dying. Making sure that the public also has access to a wide range of information has also continued as a major priority.*

*It is time for all professionals within the health Industry and related care sectors to consider what their response will be should the question of voluntary assisted dying arise in their workplace. Equally it is important that we all understand our obligations and responsibilities under the Act once it is proclaimed on 1st July 2021.*

*Soon to be released is the most comprehensive of our documents, the 'Western Australian Voluntary Assisted Dying Guidelines'. The guidelines are an important milestone in the progress towards implementation of voluntary assisted dying in Western*



## 2021 Implementation Timeline - key dates



### Pre-registration for WA Voluntary Assisted Dying Approved Training

Pre-registration now open

Practitioners who wish to participate in voluntary assisted dying will need to apply to the End of Life Care Program team in the Department of Health for access to the WA VAD Approved Training. The WA VAD Approved Training will be available in early June.

Practitioners can pre-register now to commence the validation process required for access. An information sheet on how to pre-register is available on the voluntary assisted dying website [Access to WA VAD Approved Training](#).

## **Publication of documents**

The following requirements of the *Voluntary Assisted Dying Act 2019* (the Act) are now published on the Department's website:

- **Access Standard** – As required by Part 10 of the Act, the Access Standard describes how the State will facilitate Western Australians having access to voluntary assisted dying, with a specific focus on facilitating access to voluntary assisted dying for regional residents. The Access Standard is published [here](#).
- **Approved information for a person making a First Request for voluntary assisted dying** – As per section 20 of the Act, a medical practitioner is required to give approved information to any person who makes a First Request for access to voluntary assisted dying. This information must be given regardless of whether the First Request is accepted or not. The approved information is published as a printable booklet [here](#).
- **Practitioner eligibility: requirements approved by the CEO** – To perform a role under the Act, practitioners must meet the eligibility requirements outlined in sections 17 and/or 54 of the Act, including requirements approved by the CEO (the Director General of Health). A summary of these eligibility requirements is published [here](#).
